A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE SIX (6) UNITS OF MOTOR VEHICLES IN THE AMOUNT OF THREE MILLION SIX HUNDRED THIRTY ONE THOUSAND FIVE HUNDRED PESOS (P3,631,500.00) INTENDED FOR THE MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR GIAN CARLO G. SOTTO, TO BE CHARGED AGAINST THE AVAILABLE FUNDS OF THE SAME OFFICE.




