A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO UTILIZE THE LUMP SUM APPROPRIATION OF THE 2015 GENERAL APPROPRIATIONS ORDINANCE OF QUEZON CITY FOR THE PURCHASE OF FOOD, SERVICES, AND SUPPLIES, TO BE USED BY THE OFFICE OF THE VICE MAYOR.

WHEREAS, Section 356 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that the procurement or acquisition of supplies and services by local government units (LGUs) shall be made through competitive public bidding;

WHEREAS, Section 455 (b) (l) (vi) of the same Code provides that the City Mayor shall represent the City in all its business transactions and sign on us behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance;

WHEREAS, the Commission on Audit issued Audit Observation Memorandum 2014-11-C (2013), citing as basis the Supreme Court decision in the case of Hon. Gabriel Quisumbing vs. Hon. Gwendolyn F. Garcia (G.R. No. 175527), requiring the City Council to give prior authorization to the City Mayor before any expenses or disbursements will be charged against a budget lump sum appropriation;

WHEREAS, the Office of the Vice Mayor is requesting the Quezon City Council to authorize the Quezon City Mayor to purchase the following items, specifically described as follows:

Event Management: technical assistance for conceptualizing, event planning and management, logistical preparations and production supervision in implementing the "Ocinema International	For the concept and production of the Qcinema International Film Festival 2015	Php22,568,850.00
Film Festival 2015"	Food supply for the residents of Quezon City Drug Treatment and Rehabilitation Center (QCDTRC) for 12 months, pursuant to Article IV, Section 18 of Quezon City Ordinance No. SP 1264. S-2003, which provides that treatment and rehabilitation of drug dependents, whether on voluntary or compulsory confinement, shall be conducted at the QCDTRC (Tahanan), located in Diamond Hills Subdivision, Barangay Payatas and such other centers which may hereinafter be established.	
TOTAL =		PHP35,594,264.6
