*A RESOLUTION GRANTING A SPECIAL PERMIT TO NDM BINGO CENTER TO OPERATE A BINGO HALL IN SOGO HOTEL, TRINOMA, NORTH EDSA, QUEZON CITY, FOR PURPOSES OF HOLDING BINGO GAMES SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).*

*WHEREAS, NDM Bingo Center is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with principal office at SOGO Hotel, Trinoma, North EDSA, Quezon City;*

*WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) granted NDM Bingo Center an authority to operate bingo halls where said games may be played;*

*WHEREAS, under the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Council, through a Resolution, may grant special permits or licenses;*

*WHEREAS, NDM Bingo Center, through its representative, Mr. Perry S. Lato, seeks to operate bingo halls in Quezon City which necessarily requires a special permit from the Quezon City Council;*

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a special permit to NDM Bingo Center to operate a bingo hall in Sogo Hotel, Trinoma, North EDSA, Quezon City, for purposes of holding bingo games subject to the Rules and Regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED, FURTHER, that the authority to operate a bingo hall granted herein shall be subject to the following limitations:


- a. The holding of bingo shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of bingo halls shall not include the playing of games not related to or other than bingo;
- c. The operator is enjoined to prohibit individuals below 18 years of age from playing in the above-mentioned games

RESOLVED, FINALLY, that this Special Permit to operate a bingo hall shall be for a period of two (2) years.
