RESOLUTION NO. SP- **6525**, S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE TWO (2) UNITS OF MOTOR VEHICLES INTENDED FOR THE MONITORING OF PROJECTS AND PROGRAMS OF THE OFFICE OF COUNCILOR VINCENT DG. BELMONTE, AMOUNTING TO TWO MILLION PESOS (P2,000,000.00), TO BE CHARGED IN AID OF LEGISLATION AGAINST THE AVAILABLE FUNDS OF THE SAME OFFICE.
