BAUTISTA, OF ONE (1) "RESCUE BOY" BRAND NEW MOTOR VEHICLE PACKAGE AMOUNTING TO ONE SEVEN **HUNDRED EIGHTY** *THOUSAND* PESOSMILLION : (PHP1,780,000.00), TO BE CHARGED AGAINST THE AVAILABLE FUNDS OF THE OFFICE OF COUNCILOR DIORELLA MARIA G. SOTTO-ANTONIO, INTENDED FOR THE MONITORING OF PROGRAMS AND PROJECTS ANDHEROFFICE, RESCUE**OPERATIONS** OTHERUNDEREMERGENCIES IN ALL BARANGAYS OF DISTRICT VI, QUEZON CITY.




