A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF DEVELOPMENT CORPORATION. **EXCEPTION** ECOGLOBAL | TONINETEEN-(19) STOREY CONSTRUCTION FORTHE \boldsymbol{A} WITH THREE CONDOMINIUM RESIDENTIAL/COMMERCIAL BASEMENT PARKING WITH CAR LIFTS & UPPER GROUND FLOOR AND ROOFDECK AMENITIES (ONE KATIPUNAN RESIDENCES) LOCATED AT LOT 9-B-1 TO 9-B-5 BLOCK 1 (#261) KATIPUNAN AVENUE CORNER ESTEBAN ABADA STREET, BARANGAY LOYOLA HEIGHTS, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.
