A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT REPRESENTED BY MAYOR HERBERT M BAUTISTA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE 1302ND COMMUNITY DEFENSE CENTER, NATIONAL CAPITAL REGION, REGIONAL DEFENSE GROUP, ARMY RESERVE COMMAND OF THE PHILIPPINE ARMY, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the Army Reserve Command of the Philippine Army is conducting a Special Basic Citizen Military Training (SBCMT) to Four Hundred (400) qualified volunteers who are Quezon City residents and without cost to the Quezon City Government;

WHEREAS, after completion of the Special Basic Citizen Military Training (SBCMT), the Four Hundred (400) qualified volunteers shall be enlisted in the Reserve Force and shall be utilized primarily and especially in times of disaster and/or calamities for community service and development;

WHEREAS, the 1302nd Community Defense Center, Army Reserve Command of the Philippine Army shall conduct the Special Basic Citizen Military Training (SBCMT) and shall be in-charge of the Four Hundred (400) qualified volunteers, to work on the administrative requirements before, during and after the training until they are enlisted in the Ready Reserve Infantry Company, Reserve Force of the Philippine Army;

WHEREAS, in view thereof, there is a need to authorize the Honorable Herbert M Bautista, in his capacity as the City Mayor of Quezon City, to sign the Memorandum of Agreement for the Quezon City Government;

WHEREAS, the City Council hereby authorizes Mayor Herbert M Bautista, to enter into a Memorandum of Agreement, with the 1302nd Community Defense Center, National Capital Region, Regional Defense Group, Army Reserve Command of the Philippine Army, in behalf of the Quezon City Government.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through Mayor Herbert M. Bautista, to enter into and sign the Memorandum of Agreement with the 1302nd Community Defense Center, National Capital Region, Regional Defense Group, Army Reserve Command of the Philippine Army, subject to existing laws, rules and regulations.

RESOLVED, FURTHER, that a copy of this Resolution be furnished to the 1302nd Community Defense Center, Army Reserve Command of the Philippine Army, represented by LTC Leandro M Ayop (INF) PA, for their information and guidance.

RESOLVED, FINALLY, that the Memorandum of Agreement be an integral part of this Resolution.
