A RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, WITH ST. BERNADETTE PUBLISHING HOUSE, INC., FOR THE PURCHASE AND ACQUISITION OF BASIC EDUCATIONAL BOOKS IN MATH AND SCIENCE, AMOUNTING TO TEN MILLION FIVE HUNDRED ONE THOUSAND THREE HUNDRED THIRTY SLX PESOS (P10,501,336.00), IN CONNECTION WITH THE BASIC EDUCATION ENHANCEMENT PROGRAM OF THIS CITY, TO BE DISTRIBUTED TO DIFFERENT BARANGAYS IN DISTRICTS 1,2,3,4,5, AND 6 OF QUEZON CITY.

WHEREAS, the word "Supplies" mentioned in the preceding clause is defined under Section 357 of the Local Government Code of 1991 to include everything, except real property, which may be needed in the transaction of public business or in the pursuit of any undertaking, project or activity;
