WHEREAS, in his capacity as the Acting City Accountant of the said department, he has proved and efficiently performed his duty in both the accounting and internal audit services and system of the city;

WHEREAS, Mr. Pamfilo P. Cruz ranked second place in Professional Licensure Examination for Certified Public Accountants in 1978;

WHEREAS, Mr. Pamfilo P. Cruz possesses all the qualifications and none of the disqualifications to be appointed as City Accountant of the Quezon City Government;
