A RESOLUTION URGING CONGRESS OF THE PHILIPPINES TO RENAME THE SEGMENT OF COMMONWEALTH AVENUE FROM THE ROUND-A-BOUT ENTERING BARANGAY FAIRVIEW TO THE INTERSECTION OF NORTH REGALADO AVENUE IN BARANGAY NORTH FAIRVIEW, QUEZON CITY, AS FAIRVIEW AVENUE.

WHEREAS, in the past spate of newsworthy events, there had been confusion as to where District 2 along Commonwealth Avenue ends and where District 5 begins;

WHEREAS, there is also confusion as to where the geographical jurisdiction of Barangay Fairview begins and where it ends;

WHEREAS, news providers inadvertently generalize the whole area in reporting criminal activities, from Commonwealth Avenue to the areas of the two big commercial malls in Barangays Lagro and Pasong Putik bearing the name of the said barangay to be part of Fairview, hence, casting the latter-mentioned barangay in a bad light;

WHEREAS, it is imperative to rename the subject avenue to give identity to the area upon entering the Fifth District and would also provide distinction from the Second District which the said part formerly belongs.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Congress of the Philippines to rename the segment of Commonwealth Avenue from the round-a-bout entering Barangay Fairview to the intersection of North Regalado Avenue in Barangay North Fairview, Quezon City, as Fairview Avenue.
