WHEREAS, in the current topographical feature of Quezon City, there are two (2) avenues named or called Mindanao Avenue, one in 5th District and the other extends from Ist District to 6th District;

WHEREAS, the two Mindanao Avenues are not connected with each other and are kilometers apart, hence this often causes confusion and commuters are often mislead as to which Regalado Avenue are they supposed to go;

WHEREAS, in order to distinguish one from the other, the more famous Mindanao Avenue in the 1st and 6th District shall remain as it is while the one in the 5th District shall be renamed 75th Avenue in commemoration of the 75th Founding Anniversary of the City;
