A RESOLUTION URGING THE EXECUTIVE DEPARTMENT, THROUGH THE SPECIAL DESIGN TASK FORCE OF THE ENGINEERING DEPARTMENT, TO SUBMIT A DEVELOPMENT AND IMPROVEMENT PLAN INCLUDING ITS COST ESTIMATE OF THE EXISTING PEDESTRIAN BRIDGE CROSSING LAGARIAN CREEK CONNECTING BARANGAY ROXAS AND BARANGAY KALUSUGAN.

WHEREAS, Section 16 of R. A. No. 7160, otherwise known as the Local Government Code of 1991, provides that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants";

WHEREAS, the Special Design Task Force of the Engineering Department is in charge with the services relative to public improvements, takes charge of road construction, road maintenance, construction and maintenance of all public buildings and implements the National Building Code;
