A RESOLUTION SPECIFYING THE SOURCE OF FUND OF COUNCIL RESOLUTION NO. SP-6202, SERIES OF 2015, ENTITLED, "A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO NEGOTIATE AND ENTER INTO A CONTRACT WITH THE REGISTERED OWNER OF A PARCEL OF LAND LOCATED AT BARANGAY PASONG TAMO COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBER 004-2010000300, IDENTIFIED AS LOT NO. 715-A-5 (LRC) PSD-11798 WITH GROSS AREA OF FOUR THOUSAND TWO HUNDRED SEVEN SQUARE METERS AND SIXTY SQUARE DECIMETERS (4,207.60), MORE OR LESS, TO BE UTILIZED FOR THE CONSTRUCTION OF PASONG TAMO HIGH SCHOOL, THE FUNDS FOR WHICH SHALL BE TAKEN FROM THE OFFICE OF THE CITY MAYOR," THEREBY AMENDING THE SAME.
