A RESOLUTION URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO INCLUDE IN THE CITY'S INFRASTRUCTURE PROJECT THE CONCRETE PAVEMENT OF MATAHIMIK STREET, BARANGAY TEACHER'S VILLAGE WEST, QUEZON CITY.

WHEREAS, Section 16 of the 1991 Local Government Code provides that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants";


WHEREAS, Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that the City Mayor is empowered to "Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance";

WHEREAS, the concrete pavement of Matahimik Street traversing Barangay Teacher's Village West and Barangay U.P. Village Quezon City, shall be conducive to the attainment of health and safe city living.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urges the City Mayor, Honorable Herbert M. Bautista, to include in the city's infrastructure project the concrete pavement of Matahimik Street, Barangay Teacher's Village West, Quezon City.
