A RESOLUTION REQUESTING THE QUEZON CITY GOVERNMENT THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO INSTALL BICYCLE RAMPS AT THE QUEZON CITY MEMORIAL CIRCLE UNDERPASS AND IN PHILIPPINE COCONUT AUTHORITY (PHILCOA) UNDERPASS.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, bicycles have a considerable effect on human society, in both the cultural and industrial realms;

WHEREAS, a number of cities around the world have implemented schemes known as bicycle sharing system or community bicycle programs;

WHEREAS, these initiatives complement the public transport system and offer an alternative to motorized traffic to help reduce congestion and pollution;


WHEREAS, the Quezon City Council enacted Ordinance No. SP-2369, Series 2014 entitled "An Ordinance Requiring Major Business Establishments Within the Territorial Jurisdiction of Quezon City to Provide Parking Space for Bicycles, and Providing Penalties for Violation Thereof", which was approved by the City Mayor on January 23, 2015.

NOW, THEREFORE,




