WHEREAS, the Quezon City Council enacted Ordinance No. SP-2369, Series 2014 entitled "An Ordinance Requiring Major Business Establishments Within the Territorial Jurisdiction of Quezon City to Provide Parking Space for Bicycles, and Providing Penalties for Violation Thereof", which was approved by the City Mayor on January 23, 2015.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to request, as it does hereby request the Quezon City Government through the City Mayor, Honorable Herbert M.
