Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants as provided under Section 16 of R. A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the City Mayor is empowered to represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance as stated under Section 455 (b) (1) (vi) of the said Code; ✓

NOW, THEREFORE,


