A RESOLUTION AMENDING RESOLUTION NO. SP-6196, S-2014, ENTITLED, "A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE THIRTY EIGHT (38) UNITS OF MOTOR VEHICLES INTENDED FOR THE MONITORING OF PROJECTS AND PROGRAMS OF THE OFFICE OF COUNCILOR VINCENT DG. BELMONTE AMOUNTING TO TWELVE MILLION SEVEN HUNDRED SIXTY EIGHT THOUSAND PESOS (P12,768,000.00) TO BE CHARGED IN AID OF LEGISLATION AGAINST THE AVAILABLE FUNDS OF THE SAME OFFICE".
