BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to establish and enter into a sisterhood and twinning relationship with the Bolivarian Municipality of Libertador of the Capital District of the Bolivarian Republic of Venezuela.
