RESOLUTION NO. SP- **6581**, S-2015




A RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY THE QUEZON CITY GOVERNMENT, THROUGH MAYOR HERBERT M. BAUTISTA, WITH THE WINNING BIDDER OR CONTRACTOR FOR THE PAYMENT OF MATERIALS USED AS CHRISTMAS DECORATIONS AT THE QUEZON MEMORIAL CIRCLE, IN THE TOTAL AMOUNT OF TWO MILLION SEVEN HUNDRED FORTY-SIX THOUSAND SEVEN HUNDRED THIRTY-THREE PESOS (PHP2,746,733.00), TO BE TAKEN FROM THE LUMP SUM APPROPRIATION OF THE CITY CREDIBILITY ENHANCEMENT PROGRAM OF THE 2015 GENERAL APPROPRIATIONS ORDINANCE OF QUEZON CITY.

WHEREAS, Section 356 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that the procurement or acquisition of supplies and services by local government units (LGUs) shall be made through competitive public bidding;

WHEREAS, Section 455 (b) (1) (vi) of the same Act provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance; x

WHEREAS, the Commission on Audit issued Audit Observation Memorandum 2014-11-C (2013), citing as basis the Supreme Court decision in the case of Hon. Gabriel Quisumbing vs. Hon. Gwendolyn F. Garcia (G.R. No. 175527), requiring the City Council to give prior authorization to the City Mayor before any expenses or disbursements will be charged against a budget lump sum appropriation;




WHEREAS, Mr. Tadeo M. Palma, as Quezon Memorial Circle Administrator, is requesting the Quezon City Council to ratify the contract entered into by the Quezon City Government in connection with the materials used as Christmas decorations at the Quezon Memorial Circle, in the total amount of Two Million Seven Hundred Forty-Six Thousand Seven Hundred Thirty-Three Pesos (Php2,746,733.00), the breakdown thereof is attached herein;

WHEREAS, the City Budget Department has certified that funds for the above mentioned items are available and chargeable against the lump sum appropriation of the City Credibility Enhancement Program of the General Appropriation Ordinance of Quezon City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify the contract entered into by the Quezon City Government, through Mayor Herbert M. Bautista, with the winning bidder or contractor for the payment of materials used as Christmas decorations at the Quezon Memorial Circle, in the total amount of Two Million Seven Hundred Forty-Six Thousand Seven Hundred Thirty-Three Pesos (PHP2,746,733.00), to be taken from the lump sum appropriation of the City Credibility Enhancement Program of the 2015 General Appropriations Ordinance of Quezon City.

RESOLVED, FURTHER, that the Purchase Request of the items subject of this measure be made an integral part of this resolution. Y


