RESOLUTION NO. SP- 6584 , S-2ö'l's

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO UTILIZE THE DIAMOND JUBILEE FUND OF THE 2015 GENERAL APPROPRIATIONS ORDINANCE OF QUEZON CITY FOR THE PURCHASE OF SERVICES AND SUPPLIES, IN THE TOTAL AMOUNT OF SEVEN MILLION THREE HUNDRED ONE THOUSAND TWO HUNDRED FIFTY PESOS (PHP7,301,250.00), TO BE USED IN THE 2015 QUEZON CITY INTERNATIONAL PINK FILM FESTIVAL.

WHEREAS, Section 356 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that the procurement or acquisition of supplies and services by local government units (LGUs) shall be made through competitive public bidding;

WHEREAS, Section 455 (b) (l) (vi) of the same Code provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligation and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, the Commission on Audit issued Audit Observation Memorandum 2014-11-C (2013), citing as basis the Supreme Court decision in the case of Hon. Gabriel Quisumbing vs. Hon. Gwendolyn F. Garcia (G.R. No. 175527), requiring the City Council to give prior authorization to the City Mayor before any expenses or disbursements will be charged against a budget lump sum appropriation; A

WHEREAS, Quezon City is celebrating its 75th Founding Anniversary and, in connection with the celebration, the City will be conducting various programs and projects for its residents and guest, among them is the 2015 Quezon City International Pink Film Festival that will entail the total amount of Seven Million Three Hundred One Thousand Two Hundred Fifty Pesos (Php7,301,250.00), viz:

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to utilize the Diamond Jubilee Fund of the 2015 General Appropriation Ordinance of Quezon City for the purchase of services and supplies, in the amount of Seven Million Three Hundred One Thousand Two Hundred Fifty Pesos (Php7,301,250.00), to be used in the 2015 Quezon City International Pink Film Festival.

RESOLVED, FURTHER, that the Purchase Request of the item to be purchased be made an integral part of this Resolution.
