A RESOLUTION URGING THE MANILA NORTH TOLLWAYS CORPORATION (MNTC) TO IMMEDIATELY INSTALL A SEPARATE AND EXCLUSIVE TOLL EXIT GATE TO EASE TRAFFIC LEADING TO THE PHILIPPINE ARENA IN BOCAUE, BULACAN.
