A RESOLUTION AMENDING RESOLUTION NO. SP-6364, S-2015: "A RESOLUTION AUTHORIZING THE QUEZON CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO CONTRACT WITH MADDEL INTERNATIONAL PROPERTY LIMITED FOR THE PURCHASE OF ONE HUNDRED (100) UNITS OF POP-HUT EMERGENCY RESPONSE SHELTERS AND TWENTY (20) EXTENSION UNITS, IN THE TOTAL AMOUNT OF FOURTEEN MILLION SEVEN HUNDRED TWENTY THOUSAND PESOS (PHP14,720,000.00), TO BE USED IN CALAMITY AND DISASTER SITUATIONS, AND IN THE DEVELOPMENT OF ON-SITE SOCIALIZED HOUSING PROJECTS, THEREBY INCREASING THE NUMBER OF POP-HUT EMERGENCY RESPONSE SHELTERS TO BE PURCHASED TO ONE HUNDRED TWENTY (120) UNITS AND CANCELLING THE TWENTY (20) EXTENSION UNITS ORIGINALLY INTENDED TO BE PURCHASED.

WHEREAS, the purchase of temporary shelters will be beneficial in time of calamities and disasters, as additional evacuation facilities for affected residents, and will help the implementation of projects and programs of the City Disaster Risk Reduction and Management Council (CDRRMC) and Task Force on Socialized Housing and Development on Blighted Areas (TF Housing);

WHEREAS, considering that it is more advantageous, as more victims of calamities will be aided and comforted, if the original number of complete shelters will be increased to one hundred twenty (120) units, while at the same time cancelling the extension units intended to be purchased by the city government, the TF Housing is requesting that Resolution No. SP-6364, S-2015, be amended accordingly;

WHEREAS, the total cost for the one hundred twenty (120) units of Pop-Hut Emergency Response Shelter amounts to fifteen million forty two thousand pesos (Php15,042,000.00), or one hundred twenty five thousand three hundred fifty pesos (Php125,350.00) per unit.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend Resolution No. SP-6364, S- 2015: entitled "A Resolution Authorizing The Quezon City Mayor, Honorable Herbert M. Bautista, To Enter Into A Contract With MADDEL International Property, Limited, For The Purchase Of One Hundred (100) Units Of Pop-Hut Emergency Response Shelters And Twenty (20) Extension Units, In The Total Amount of Hundred Twentv Thousand Million Seven Fourteen (Php14,720,000.00), To Be Used In Calamity And Disaster Situations And In The Development Of On-site Socialized Housing Projects", thereby increasing the number of Pop-Hut Emergency Response Shelters to be purchased to one hundred twenty (120) units and cancelling the twenty (20) extension units originally intended to be purchased.
