WHEREAS, the Quezon City Barangay Seal of Good Housekeeping is a collaborative project of the Department of the Interior and Local Government (DILG) and the Quezon City government which primarily aims to give primacy to the principle of effective performance, accountability, transparency, and citizens' participation in local governance;

WHEREAS, the Seal will be awarded to Barangays that perform well in their internal housekeeping, such as local legislation (paggawa ng batas), development planning (pagplano para sa kaunlaran), resource allocation and utilization (paglalaan at paggamit ng kaban ng bayan), service delivery (paghatid ng serbisyo), community engagement (paghikayat sa komunidad), and human resource management (pagangasiwa ng yamang tao);

WHEREAS, Barangay St. Ignatius of the Third District of Quezon City has been awarded as a Good Financial Housekeeping Awardee, and as one of the Barangays with Best Practices and Innovations for their use of Solar Panels, both being Special Awards of the Seal of Good Housekeeping.
