RESOLUTION NO. SP- **6620** S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE TO 745 INFORMAL SETTLER FAMILIES (ISFs) FROM SITIO SAN ROQUE, NORTH TRIANGLE, BARANGAY BAGONG PAG-ASA, QUEZON CITY, WHO WERE RELOCATED VOLUNTARILY AT THE RESETTLEMENT SITE OF THE NATIONAL HOUSING AUTHORITY (NHA) IN GRACEVILLE, SAN JOSE DEL MONTE CITY, BULACAN, AMOUNTING TO ONE THOUSAND PESOS (PHP1,000.00) EACH OR A TOTAL AMOUNT OF SEVEN HUNDRED FORTY FIVE THOUSAND PESOS (PHP745,000.00), TO FUND THE BUILDING PERMIT FEES BEING CHARGED BY SAN JOSE DEL MONTE CITY GOVERNMENT.

WHEREAS, a total of 745 Informal Settler Families (ISFs) from Sitio San Roque, North Triangle, Barangay Bagong Pag-Asa, Quezon City, were relocated to NHA resettlement site in Graceville, San Jose Del Monte City, Bulacan, purposely to pave the way for the development of North Triangle, being part of the Quezon City Central Business District (QC-CBD) and to finally formalize the tenurial status of said ISFs; *✓*

WHEREAS, the 745 relocatees from North Triangle, represented by Mr. Edwin M. Nacpil, Chairperson of SRCC Multi-Purpose Cooperative, through a communication letter addressed to the Honorable City Mayor, Herbert M. Bautista dated October 27, 2014, have requested the Quezon City Government (LGU-QC) to shoulder the Building Permit fees being charged by San Jose Del Monte City Government in the amount of One Thousand Pesos (Php 1,000.00) per relocatee or a total amount of Seven Hundred Forty Five Thousand Pesos (Php745,000.00);

WHEREAS, to extend the aforementioned financial assistance, as a form or gesture of goodwill to the 745 relocatees from Quezon City and also to the receiving local government unit, there is a need for the Quezon City Council to authorize the Honorable City Mayor to allocate and release funds for same.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to extend financial assistance to 745 Informal Settler Families (ISFs) from Sitio San Roque, North Triangle, Barangay Bagong Pag-Asa, Quezon City, who were relocated voluntarily at the resettlement site of the National Housing Authority (NHA) in Graceville, San Jose Del Monte City, Bulacan, amounting to One Thousand Pesos (Php1,000.00) each or a total amount of Seven Hundred Forty Five Thousand Pesos (Php745,000.00), to fund the building permit fees being charged by San Jose Del Monte City Government.
