A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH MAYOR HERBERT M. BAUTISTA, TO UTILIZE THE LUMP SUM APPROPRIATION OF THE 2015 GENERAL APPROPRIATIONS ORDINANCE OF QUEZON CITY, FOR THE PURPOSE OF ENGAGING THE SERVICES OF A REPUTABLE PRODUCTION OUTFIT AND FOR THE PAYMENT OF HONORARIUM FOR THE MANUEL L. QUEZON GAWAD PARANGAL SELECTION BOARD MEMBERS AND SECRETARIAT, IN CONNECTION WITH THE "76<sup>TH</sup> MANUEL L. QUEZON GAWAD PARANGAL" PRESENTATION.

WHEREAS, Section 356 of Republic Act No. 7160 mandates that "the procurement or acquisition of supplies and services by local government units shall be made through competitive public bidding";

WHEREAS, Section 455 (b), (1), (vi) of R.A. No. 7160 states that, "The City Mayor shall represent the City in all business transactions and sign in its behalf all bonds, contracts, and obligation, and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance";

WHEREAS, the Commission on Audit (COA) issued Audit Observation Memorandum 2014-11-C, S-2013, "requiring the City Council to give prior authorization to the City Mayor before any expenses/disbursements charged against a lump sum appropriation can be made" citing the Supreme Court case of Hon. Gabriel Quisimbing vs Hon. Gwendolyn F Garcia (G.R. No. 175527) as basis;

WHEREAS, it is a form of good governance to utilize the resources and/or funds of the City as efficiently and as effectively as possible to finance the delivery of basic services, and the enhancement of various social and economic activities for the prosperity and progress of the people of the City;

WHEREAS, the Gawad Parangal is the highest form of recognition given by the Quezon City Government to honor its outstanding individuals and institutions who contributed to the realization of the City's vision as a quality community, as well as to the progress and betterment of the Filipino as a whole;

WHEREAS, to make the "76<sup>th</sup> Manuel L. Quezon Gawad Parangal" Presentation a success, it shall require the services of a reputable production outfit that shall take charge of its promotion, production and overall presentation, as well as the payment of honorarium for its Selection Board Members and Secretariat, for their industry and creativity in crafting this year's event;

WHEREAS, the descriptions/specifications and cost of the mentioned items to be funded from the lump appropriation are as follows:

RESOLVED, FURTHER, that the City Mayor is hereby authorized to enter into a contract with the winning bidder and/or contractor in connection with the procurement authorized hereof. X

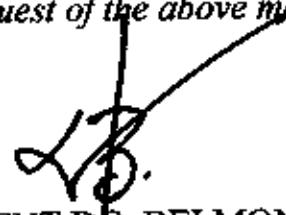
