RESOLUTION NO. SP- **6626**, S-2015

**A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) MOTOR VEHICLE IN THE AMOUNT OF SIX HUNDRED FIFTY-FIVE THOUSAND PESOS (P655,000.00) TO BE UTILIZED BY THE CITY ADMINISTRATOR'S OFFICE TO FACILITATE MOBILITY OF ITS PERSONNEL AND FOR THE EFFECTIVE IMPLEMENTATION, OPERATION, AND MONITORING OF ITS PROGRAMS AND PROJECTS, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.**

*WHEREAS, a request was made by the Office of the City Administrator to procure one (1) motor vehicle for the implementation, operation, and monitoring of their programs and/or projects; †*





