RESOLUTION NO. SP- **6628**, S-2015

**A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH MAYOR HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT/AGREEMENT FOR THE PURCHASE OF GOODS (VARIOUS GROCERY ITEMS) FOR THE ANNUAL CHRISTMAS GIFT GIVING ACTIVITY OR "PAMASKONG HANDOG" PROJECT. IN THE AMOUNT OF TWENTY FOUR MILLION, FIVE HUNDRED ONE THOUSAND, FIVE HUNDRED EIGHTEEN PESOS (PHP24,501,518.00), AS FOOD ASSISTANCE FOR THE LESS FORTUNATE FAMILIES RESIDING IN QUEZON CITY, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.**

*WHEREAS, Section 365 of Republic Act No. 7160, mandates that "the procurement or acquisition of supplies and services by local government units shall be made through competitive public bidding";*

*WHEREAS, Section 455 (b), (i), (vi) of R.A. No. 7160 states that, "the City Mayor shall represent the City in all business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";*

*WHEREAS, the Commission on Audit (COA) issued Audit Observation Memorandum 2014-11-C, S-2013, "requiring the City Council to give prior authorization to the City Mayor before any expenses/disbursements charged against a lump sum appropriation can be made" citing the Supreme Court case of Hon. Gabriel Quisimbing vs. Hon. Gwendolyn F. Garcia (G.R. No. 175527) as basis;*

WHEREAS, the celebration of the Yuletide season would entail the use of the following supplies and services: 1) Events Management; 2) Public Celebration supplies and materials; 3) Services; and 4) Lease and Rental;

WHEREAS, the "Pamaskong Handog 2015" will highlight the sharing of grocery items to be given to the less fortunate families in Quezon City during Christmas season through the Social Services Development Department;


WHEREAS, there exists an Approved Budget of the Contracts that is already available /chargeable against the funds of the Office of the Mayor, as certified by the Budget Department;

WHEREAS, the "Pamaskong Handog 2015" Project shall require the procurement of goods/various grocery items to be distributed for the less fortunate families in Quezon City;



NOW, THEREFORE,


