A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMET THROUGH MAYOR HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTORIZED VEHICLE, TO FACILITATE THE MOBILITY AND EFFICIENT OPERATIONS OF THE QUEZON CITY HUMAN MILK BANK, SUBJECT TO EXISITING LAWS, RULES AND REGULATIONS.

WHEREAS, Section 356 of Republic Act No. 7160, mandates that "the procurement or acquisition of supplies and services by local government units shall be made through competitive public bidding";

WHEREAS, Section 455 (b), (i) (vi) of R.A. No. 7160, states that, "The City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, the Commission on Audit (COA) issued Audit Observation Memorandum 2014-11-C, S-2013, "requiring the City Council to give prior authorization to the City Mayor before any expenses/disbursements charged against a lump sum appropriation can be made" citing the Supreme Court case of Hon. Gabriel Quisimbing vs. Hon. Gwendolyn F. Garcia (G.R. No. 175527) as basis;

WHEREAS, the Quezon City Government launched its very first Human Milk Bank at the Quezon City General Hospital and Medical Center (QCGHMC) last March 23, 2015. The Quezon City Human Milk Bank (QCHMB) "aims to share human milk to mothers with premature babies and malnourished children. To make this happen, healthy breastfeeding mothers are encouraged to share their own breast milk to save the lives of other children." I

WHEREAS, pursuant to Ordinance No. SP-2195, Series of 2012, entitled "An Ordinance Establishing A Human Milk Bank in the Quezon City owned Hospitals for the Support of Women and Children in Need of Breastmilk", as stated in its Implementing Rules and Regulations (IRR), to wit:

"Section 20. APPROPRIATION. A necessary budget shall be allotted for the establishing of the Human Milk Bank which fund shall be taken from the annual budget of the City for the year 2013. Thereafter, an annual budget shall be allocated for its continuous operation."

WHEREAS, there exists an Approved Budget for One (1) unit Motorized Vehicle that is already available/chargeable against the funds of the Office of the Mayor, as certified by the Budget Department;

WHEREAS, the request Project shall require the necessary supplies, equipment and manpower, more particularly described as follows, to wit:

Project Title : One (1) unit motorized vehicle Specifications:

"Overall Length: 4, 155mm (standard wheelbase); overall width: 1,655mm; overall height: 1,865mm; wheelbase: 2,625mm (standard); thread (front/rear): 1,430/1,435mm; payload: 1,045kg (standard); Engine type: G16A SOHC, 16 valve gasoline fed Engine with multi-point injection system Tank

Capacity: 46 liters; maximum power: 91ps/5750; Transmission: 5 speed manual; Suspension (front): Mcpherson Strut and coil spring; suspension (rear): Rigid Axle and leaf spring; brakes: Front: ventilated disc. Rear: leading and trailing drums; Wheels; 14" steel rims; Tires: 185/80 R14PR; seating Capacity (front): 8 persons; Aircon System: Single System; Displacement: 1590cc; No of cylinders: 4; Type: AUV."

Approved Budget: Eight Hundred Thousand Pesos (PhP800,000.00)

WHEREAS, the said Purchase Request (PR) submitted to the Bids and Awards Committee is in accordance with law and will serve the best interest and advantage of the Quezon City Government.

Bautista, to purchase one (1) unit of motorized vehicle, to facilitate the mobility and efficient operations of the Quezon City Human Milk Bank, subject to existing laws, rules and regulations."

RESOLVED, FURTHER, that a copy of this Resolution be given to the City Budget Department, City Accounting Department, Commission on Audit-Quezon City Field Office, and the Department of the Interior and Local Government, for their information and guidance.
