WHEREAS, a letter from the Municipal Mayor of Tolosa, Leyte, Honorable Erwin C. Ocaña. was sent to the Honorable Quezon City Mayor, Herbert M. Bautista, inviting the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC) Disaster Action Team (DAT) to the 148<sup>th</sup> Tolosa Day Celebration;

WHEREAS, on May 6, 2015, in response to the request of Hon. Mayor Erwin C. Ocaña, the Quezon City Government sent the Quezon City Disaster Risk Reduction and Management Council Staff, to conduct trainings in Tolosa, Leyte. Among the topics that were given by the QCDRRMC are the overview on the Rapid Damage Assessment and Needs Analysis (RDANA) and the Incident Command System (ICS), presented by Mr. Karl Michael E. Marasigan and Mr. Lester A. Morfe, respectively;

WHEREAS, aside from the training programs on disaster management, a Medical Mission and Community Services were conducted at the Rural Health Center conducted by the new Municipal Health Doctors together with Dr. Felisa G. Luna, Medical Officer III, from the Quezon City Health Department on May 7, 2015;

WHEREAS, Section 4 of City Ordinance No. SP-2345, S-2014, otherwise known as the General Appropriations Ordinance of Quezon City, provides that other contracts whose amount is duly appropriated as Lump Sum Appropriations or for Special Activities, shall require a Sangguniang Panlungsod Resolution granting the City Mayor authority to enter and sign such contracts:

WHEREAS, in the case of Hon. Gabriel Quisumbing vs. Gwendolyn F. Garcia (G.R. No. 175527), the Supreme Court requires the City Council to give prior authorization to the City Mayor before any expenses/disbursement charged against a lump sum appropriation can be made.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify the contract entered into by Honorable Mayor Herbert M. Bautista in relation to the Training Programs and Medical Mission of the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC) held on May 6 and 7, 2015 at Tolosa, Leyte.
