WHEREAS, the Quezon City Fire Department possesses only one (1) firetruck with aerial ladder platform and which is presently under maintenance work due to ordinary wear and tear.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to request, as it does hereby request the City Mayor, Honorable Herbert M. Bautista, to enter into a contract with a reputable contractor for the purchase of a firetruck with aerial ladder platform for the firefighting operations of the Quezon City Fire Department, and for the protection and safety of its constituents.
