RESOLUTION NO. SP- **6637**, S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE FOUR (4) UNITS OF ALL PURPOSE VEHICLE (APV) GA PATROL CAR IN THE AMOUNT OF TWO MILLION FIVE HUNDRED EIGHTY FOUR THOUSAND PESOS (PHP2,584,000.00), TO BE DONATED TO DIFFERENT POLICE STATIONS IN QUEZON CITY, TO BE CHARGED AGAINST THE FUNDS OF THE OFFICE OF COUNCILOR JESUS MANUEL C. SUNTAY.

WHEREAS, under Section 2, Article I of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, it is the policy of the State to promote the ideals of good governance in all its branches, departments, agencies, subdivisions and instrumentalities including government-owned and controlled corporations and local government units;

WHEREAS, to ensure that such functions be fully performed by the different police stations of Quezon City, there is an imperative need to provide them necessary motor vehicles;

WHEREAS, the Office of Councilor Jesus Manuel C. Suntay desires to procure four (4) units of APV GA Patrol Car to be used for the aforesaid purposes, with the following general specifications:

- *Equipped with G16A SOHC 1.6 liter 16-valve gasoline fed engine multi-point injection system; maximum output.*
- *91 HP@ 5,750rpm; Max Torque : 127 Nm @ 4500rpm Brakes; Front: ventilated discs; rear: leading & trailing drums; 5-speed manual transmission;*
- *Front suspension: McPherson strut with coil spring; Rear Suspension: rigid axle & lead Spring; Audio.*

- System: 1 DIN AM/FM Tuner, CD MP3 & AUX; 2 Speaker.
- Steering: Rack & Pinion with Power Assist; Fuel Tank Capacity: 46 Liters; Single Air-con System; 8 Passengers;
- Overall Height: 1865mm; Ground Clearance; 175mm Gross Vehicle Weight: 1,950kg.

WHEREAS, pursuant to Section 455 (b) (1) (vi) of RA No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign on its behalf all bonds, contracts, and obligations and such other documents upon the authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to purchase four (4) units of All Purpose Vehicle (APV) GA Patrol Car in the amount of Two Million Five Hundred Eighty Four Thousand Pesos (Php2,584,000.00) to be donated to different Police Stations in Quezon City, to be charged against the funds of the Office of Councilor Jesus Manuel C. Suntay.

RESOLVED, FURTHER, that a copy of this Resolution be given to the City Budget Department, City Accounting Department, Commission on Audit-Quezon City Field Office, and the Department of the Interior and Local Government, for their information and guidance.


