**A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT (SUP) TO CNZ CONSTRUCTION CORPORATION, FOR THE CONSTRUCTION OF A THIRTY (30) METER THREE (3)-LEGGED SELF SUPPORTING TOWER, BTS ANTENNAS, LOCATED AT NO. 777 CARLOS STREET, BARANGAY SAN BARTOLOME, NOVALICHES, QUEZON CITY.**

*WHEREAS, CNZ Construction Corporation, an authorized contractor of Hi-Frequency Telecommunication, Inc., is applying for a Special Use Permit (SUP) for the construction of a 30 meter three (3)-legged Self Supporting Tower, BTS antennas located at No. 777 Carlos Street, Barangay San Bartolome, Novaliches, Quezon City;*

*WHEREAS, in pursuance with the provisions of Article VII, Section 2, (D) (2) of Ordinance No. SP-918, S-2000, as amended, otherwise known as the Quezon City Comprehensive Zoning Ordinance, where the public welfare demands, however, radio transmitting stations maybe located in some residential zones provided the preceding condition is complied with strictly, and no interference with or damage to local electrical appliances or the property will likely result;*

*WHEREAS, Barangay San Bartolome issued a certification/ clearance granting the proposed installation and construction of the said tower last February 2015 as the said barangay interposes no objection to the said project;*
