RESOLUTION NO. SP- 6647, S-2016

A RESOLUTION URGING THE TRICYCLE FRANCHISING BOARD (TFB) TO EFFECT AN IMMEDIATE REVIEW OF TRICYCLE-FOR-HIRE FARE IN QUEZON CITY AS TO MAKE IT ATTUNED TO THE SOCIO-ECONOMIC EXIGENCIES THAT HAVE A DIRECT BEARING ON THE COST OF OPERATION THAT EVENTUALLY AFFECT THE INCREASE /DECREASE IN THE FARE OF TRICYCLES.

WHEREAS, it is the declared policy of the Quezon City Government to promote and protect the welfare of the riding public;

WHEREAS, in view of the continuous rollback of domestic oil prices and decrease in the price of oil in the international market, there is an imperative need for the public transport sector, specifically tricycles to make a corresponding decrease in the cost of fare;

WHEREAS, considering other factors in operating tricycles such as inflation rate, foreign exchange movement and maintenance cost, the TFB can review tricycle fare that would redound to the economic benefit of the riding public;

WHEREAS, Ordinance No. SP-1885, S-2008, entitled "An Ordinance Imposing a Provisional Fare Roll Back in all tricycle for hire in Quezon City" was enacted to impose reasonable fare for the riding public; ✓

WHEREAS, Ordinance No. SP-2337, S-2014, entitled, "An Ordinance Adopting the Quezon City Tricycle Management Code of 2014" was enacted to provide fare structure which vary on the distance;


WHEREAS, considering that tricycle for hire is impressed with public interest its operation must be effectively managed and controlled in order to achieve the aims and purposes for which transport facilities are to serve;

WHEREAS, guided by the primordial consideration of serving the best interest of the riding public and tricycle sector, it is imperative to encourage the TFB to review the fare of tricycle for hire.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Tricycle Franchising Board (TFB) to effect an immediate review of tricycle-for-hire fare in Quezon City as to make it attuned to the socio-economic exigencies that have a direct bearing on the cost of operation that eventually affect the increase/decrease in the fare of tricycles.
