WHEREAS, the Cheerleading Philippines, the cheerleading arm of the Gymnastics of the Philippines nominated the Quezon City Performing Arts Foundation, Inc. (QCPADFI) to represent the country in the 8<sup>th</sup> IFC Cheerleading World Championships in Berlin, Germany from November 21-22, 2015;

WHEREAS, this is the first time that these dance scholars of our own, represented the country in this prestigious event;

WHEREAS, the Philippines won a Silver Medal in the Junior Cheer Dance Doubles Category garnering a score of 93 points in day one (1) and 101 points in day two (2);
