A RESOLUTION AUTHORIZING THE ISSUANCE OF CERTIFICATE OF EXCEPTION TO SM DEVELOPMENT CORPORATION FOR THE CONSTRUCTION OF "VINE RESIDENCES" LOCATED AT LOT 976-B-1 & LOT 441 QUIRINO HIGHWAY, BARANGAY SAN BARTOLOME, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.

WHEREAS, SM Development Corp., is applying for a Certificate of Exception for the construction of a five (5) — twelve (12) storey residential condominium building with lower ground floor parking at the portion of tower 1, 2 and 5 located at Lot 976-B-1 & Lot 441 Quirino Highway Barangay San Bartolome, Quezon City;

WHEREAS, the proposed Project shall not adversely affect public health, safety and welfare, and is in keeping with general pattern of development in the community;

WHEREAS, in accordance with the provision of Article IV, Article V, Article VI Section 3 & Section 4, Article VIII and Article IX, Section 18 of Ordinance No. SP-918, S-2000 as amended, and its implementing rules and regulations, an Exception is required for a project to which the proposed undertaking falls under.
