RESOLUTION NO. SP- **6661**, S-2015

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT THROUGH MAYOR HERBERT M. BAUTISTA, TO APPROPRIATE THE AMOUNT OF SIXTY SEVEN MILLION NINE HUNDRED EIGHTY NINE THOUSAND SIX HUNDRED THIRTY THREE PESOS AND EIGHTY CENTAVOS (PHP 67,989,633.80), FOR THE UTILIZATION AND EFFECTIVE IMPLEMENTATION OF THE "QUEZON CITY STREETLIGHTS PROGRAM, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, "The City Mayor shall represent the City in all business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance";

WHEREAS, Section 455 (4) of the Local Government Code of 1991 provides that the city shall "ensure the delivery of basic services and provision of adequate facilities as provided for under Section 17 of this Code and, in addition thereto, shall: ✕

- (i) *Ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the city, x x x ; and*
- (ii) *Coordinate the implementation of technical services, including public works and infrastructure programs, rendered by national offices in the case of highly urbanized and independent component cities, and by national and provincial offices in the case of component cities.*

*WHEREAS, the Environment Policy Management Council (EPMC) was constituted to implement all policies adopted by the Quezon City Government concerning the environment and to recommend and adopt measures implementing such policies;*

*WHEREAS, Resolution No. 2011-04, Series of 2011, was adopted for the purpose of the reinstallation, rehabilitation, repair and maintenance of HPS streetlights to light emitting diodes (LED) to reduce power consumption and protect the environment by using energy efficient lamps as a mitigating measure against climate change;*

*WHEREAS, there is a necessity for the city to lessen its power consumption and at the same time provide quality lighting service to its constituents;*

*WHEREAS, reduced power consumption will mean reduced greenhouse gas emissions, thus, a cleaner and greener environment for Quezon City and the whole nation;*

*WHEREAS, the savings derived from the Quezon City Energy Efficient Street Lightning Program may then be diverted to other projects by the Quezon City Government;*

*WHEREAS, the primary objective is to implement the Quezon City Streetlights Program by creating and increasing the City's illumination, thus providing a better and safer Quezon City at a lower construction cost; and*

*WHEREAS, for the immediate and effective implementation of the Quezon City Streetlights Program, there is a need to authorize the Quezon City Government through Mayor Herbert M. Bautista, to appropriate the amount of Sixty Seven Million Nine Hundred Eighty Nine Thousand Six Hundred Thirty Three Pesos and Eighty Centavos (PHP 67,989,633.80), to defray the cost of the reinstallation, rehabilitation, repair and/or maintenance of the Quezon City Streetlights. ✓*
