SANTIAGO, AND JAIME M. SANTIAGO, MARRIED TO MA. LUISA R. SANTIAGO, LOCATED IN BARANGAY BATASAN HILLS, QUEZON CITY.

WHEREAS, the Quezon City Government, a local government unit created and existing under and by virtue of the laws of the Philippines, with principal office and postal address at Quezon City Hall Compound, Elliptical Road, Diliman. Quezon City;

WHEREAS, Daniel Santiago III, married to Corazon C. Santiago, and Jaime M. Santiago, married to Ma. Luisa R. Santiago, both resident of No. 142-A N. Domingo Street, San Juan, Metro Manila, are the true and lawful owner of a parcels of land described as Lot 1-B-3 (Right-of-Way), Lot 1-A-8 (Alley) and Lot 1-B-1-M (Alley);

WHEREAS, the owners are willing to donate the said lots as Right-of-Way and Alleys in consideration of any possible improvements that may be made and introduced by the Quezon City Government on the subject lots;
