A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT (SUP) TO COMM TREND CONSTRUCTION CORPORATION, FOR THE INSTALLATION AND CONSTRUCTION OF A 24.60 METER MONOPOLE TOWER AND ITS SUPPORT FACILITIES, LOCATED IN VALIENT STREET. DON MARIANO MARCOS AVENUE, BARANGAY FAIRVIEW, QUEZON CITY.

WHEREAS, Comm Trend Construction Corporation, sub-contracted by Smart Communications, Inc., is applying for a Special Use Permit (SUP) for the installation and construction of a cellsite tower and support facilities located at Valuent Street, Don Mariano Marcos Avenue, Fairview Quezon City;

WHEREAS, pursuant to the provisions of Ordinance No. SP-918, S-2000, as amended, or The Quezon City Comprehensive Zoning Ordinance it should be made certain that no interference shall be made of such installation to residential areas and that the sound maintenance of such tower shall be the exclusive responsibility of the proponent and/or persons operating them;

WHEREAS, Barangay Fairview issued a Resolution No. SB-05-001, S-2013, granting the proposed installation and construction of the said tower last June 14, 2013 as the said barangay interposes no objection to the said project.

WHEREAS, the applicant has complied with the requirements for its application for the issuance of a Special Use Permit, and that Barangay Fairview and their residents therein interpose no objection.
