WHEREAS, Megaworld Corporation, a corporation duly organized and existing under Philippine laws, with office address at 7th Floor, 1880 Eastwood Avenue. Eastwood City Cyberpark, No. 1880 E. Rodriguez Jr. Avenue, Bagumbayan, Quezon City, represented by its Commercial Division. Marketing and Business Development Head, Ms. Teresa Felicidad Pesigan – Valentino:

WHEREAS, Megaworld shall shoulder any cost and/or expense for the event that is in excess of the amount contributed by the QC Government as stated in the Memorandum of Agreement;

WHEREAS, Section 25 of City Ordinance No. SP-2345, S-2014, otherwise known as the General Appropriations Ordinance of Quezon City, provides that all bonds, contracts, obligations and such other documents which the City Mayor, upon the authority of the Sangguniang Panlungsod, may have signed or executed in representation of the City, shall be confirmed and ratified through a separate resolution or ordinance enacted by the Sangguniang Panlungsod.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify the Memorandum of Agreement entered into by the City Mayor, Honorable Herbert M. Bautista, with Megaworld Corporation for the conduct of New Year's Eve countdown entitled, "The 2015 Eastwood – Quezon City New Year Celebration" held at Eastwood City.
