RESOLUTION NO. SP-\_\_\_\_\_, S-2016

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH MAYOR HERBERT M. BAUTISTA, TO APPROPRIATE THE AMOUNT OF TEN MILLION ONE HUNDRED NINETY EIGHT THOUSAND AND FIFTY PESOS (PHP10,198,050.00), FOR THE UTILIZATION AND EFFECTIVE IMPLEMENTATION OF THE QUEZON CITY STREETLIGHTS PROGRAM, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, pursuant to Section 455 (b), (1), (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, "the City Mayor shall represent the City in all business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;"

WHEREAS, Section 455 (4) of the said Code also provides to "ensure the delivery of basic services and the provision of adequate facilities as provided for under Section 17 of this Code and, in addition thereto, shall:

- (i) Ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the city, xxx; and
- (ii) Coordinate the implementation of technical services, including public works and infrastructure programs, rendered by national offices in the case of highly urbanized and independent component cities, and by national and provincial offices in the case of component cities.

WHEREAS, the Quezon City Energy Efficient Street Lighting Program through the Quezon City Taskforce on Streetlights (QCTFSL), in partnership with the National Road Lighting Program of the Road Board through the Department of Public Works and Highways (DPWH) for the purpose of the reinstallation, rehabilitation, repair and maintenance of pulled-out and/or turned-over Quezon City Streetlights;


WHEREAS, the primary objective of the partnership is to implement the Quezon City Streetlights Program by creating and increasing the City's illumination, thus providing a better and safer Quezon City at a lower construction cost; and

WHEREAS, for the immediate and effective implementation of the Quezon City Streetlights Program, there is a need to authorize the Quezon City Government, through Mayor Herbert M. Bautista, to appropriate the amount of Ten Million One Hundred Ninety Eight Thousand And Fifty Pesos (PhP10,198,050.00), to be taken out of the Twenty Percent (20%) Community Development Fund (CDF) to defray the cost of the reinstallation, rehabilitation, repair and/or maintenance of pulled-out and/or turned-over Quezon City Streetlights.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through Mayor Herbert M. Bautista, to appropriate the amount of Ten Million One Hundred Ninety Eight Thousand and Fifty Pesos (Php10,198,050.00) for the effective implementation of the Quezon City Streetlights Program, subject to existing laws, rules and regulations.
