WHEREAS, Agubellina Fuel Distributors, Inc. has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the aforementioned Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction, installation and operation of a gas station will provide employment and promote economic development in the City.
