A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE TWO (2) UNITS OF MOTOR VEHICLE INTENDED FOR MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR DIORELLA MARIA SOTTO-ANTONIO AMOUNTING TO ONE MILLION SIX HUNDRED EIGHTY THOUSAND PESOS (PHP1,680,000.00) TO BE CHARGED AGAINST THE AVAILABLE FUNDS OF THE OFFICE OF THE SAID CITY COUNCILOR.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through the City Mayor, Honorable Herbert M. Bautista, to purchase two (2) units of motor vehicle intended for monitoring purposes of the Office of Councilor Diorella Maria Sotto-Antonio, City Councilor, 6th District, Quezon City, to be charged against the available funds of the Office of the said City Councilor.
