A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE TO BE USED AS AMBULANCE FOR DISTRICT II, A PROGRAM INITIATED BY THE OFFICE OF COUNCILOR RAMON P. MEDALLA IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP1,500,000.00), TO BE TAKEN FROM THE AVAILABLE FUNDS OF THE CITY MAYOR.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through the City Mayor, Honorable Herbert M. Bautista, to purchase one (1) unit of motor vehicle to be used as Ambulance for District II, a program initiated by the Office of Councilor Ramon P. Medalla in the amount of One Million Five Hundred Thousand Pesos (Php1,500,000.00), to be taken from the available funds of the City Mayor.
