RESOLUTION NO. SP- 6694

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE FIFTEEN (15) UNITS OF MOTORCYCLE WITH SIDECAR, AND ONE (1) UNIT OF MOTORCYCLE WITHOUT SIDECAR INTENDED FOR THE MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR MELENCIO T. CASTELO, JR., IN THE TOTAL AMOUNT OF FOUR MILLION FIVE HUNDRED THOUSAND PESOS (PHP4,500,000.00), TO BE CHARGED AGAINST THE FUNDS OF THE OFFICE OF THE SAID CITY COUNCILOR.

WHEREAS, the Quezon City Government intends to procure motor vehicle intended for the monitoring of programs and projects of the Office of Councilor Melencio T. Castelo, Jr., described as follows:

I. Motorcycle (150cc) with Customized Designed Semi-Stainless Sidecar Automotive Paint Finish color blue, Signal Light Front & Rear, Galvanize and Stainless Body, Mag wheel Tire, with Molye Suspension, Back-to-Back Seater for 5 persons, Seat belt at the Back, w/ leaf-spring suspension sticker Printing and Logo Front & Side, Rain Cover, utility box, wing Shield Rigid frame Custom Bumper Bike support, Blinker LED Light Blue and Red, Signboard at the Top with LED light and remote control Solar Panel Rechargeable Li-ion Battery, Upholstery and Accessories, Includes: GSIS TPL Insurance and LTO Registration.

Cost: Two Hundred Eighty Nine Thousand Pesos (P289,000.00) each.

2. Motorcycle (150 cc) without sidecar

Engine Type: 4-stroke, SOHC 2 valves, single cylinder

Cost: One Hundred Sixty Five Thousand Pesos (P165,000.00)

WHEREAS, pursuant to Administrative Order No. 1, amending Administrative Order No. 233, Series of 2008, the City Mayor, Honorable Herbert M. Bautista, has already sought permission and authorization from the Department of the Interior and Local Government (DILG) in his letter addressed to Mr. Juan Jovian E. Inginiero, CESO IV, City Director of DILG for acquisition of the above-described motor vehicle amounting to P4,500,000.00 which amount is in the 2015 Annual Budget of the City Government under the City Council of Quezon City;

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through the City Mayor, Honorable Herbert M. Bautista, to purchase fifteen (15) units of motorcycle with sidecar, and one (1) unit Motorcycle (150cc) without sidecar, intended for the monitoring of programs and projects of the Office of Councilor Melencio T. Castelo, Jr., in the total amount of Four Million Five Hundred Thousand Pesos (P4,500,000.00), to be charged against the funds of the Office of the said City Councilor.
