
A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE IN THE AMOUNT OF NINE HUNDRED NINETY FIVE THOUSAND PESOS (PHP995,000.00), INTENDED FOR THE MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR FRANZ S. PUMAREN, TO BE CHARGED AGAINST THE AVAILABLE FUNDS OF THE SAME OFFICE.
