RESOLUTION NO. SP- 6698 , S-2016

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE TEN (10) UNITS OF MOTOR VEHICLE TO BE DONATED TO TEN (10) BARANGAYS OF DISTRICT VI AMOUNTING TO EIGHT MILLION FOUR HUNDRED THOUSAND PESOS (PHP8,400.000.00) TO BE CHARGED AGAINST THE FUNDS OF THE OFFICE OF THE COUNCILOR DIORELLA MARIA G. SOTTO-ANTONIO.

WHEREAS, pursuant to Section 455 (b) (l) (vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through the City Mayor, Honorable Herbert M. Bautista, to purchase ten (10) units of motor vehicle to be donated to ten (10) Barangays of District VI amounting to Eight Million Four Hundred Thousand Pesos (Php8,400,000.00) to be charged against the funds of the Office of Councilor Diorella Maria G. Sotto-Antonio.
