WHEREAS, Pilipinas Shell Petroleum Corporation is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of a new Shell gasoline refilling station along Commonwealth Avenue corner Pearl Street, Barangay Fairview, Quezon City;

WHEREAS, in accordance with the following provisions, particularly Articles III (Section 3), V, VI, and Article IX (Section 18) of Quezon City Ordinance No. SP-918, S-2000, otherwise known as "The Quezon City Comprehensive Zoning Ordinance and its Implementing Rules and Regulations, a Special Use Permit is required and may be issued on projects falling under the said provisions;
