WHEREAS, former Councilor Cielito E. Del Mundo, a singer, actress, television host, and civic leader widely known as "Mahal," died at the age of eighty (80) on January 9, 2016 in Phoenix, Arizona;

WHEREAS, she was known for her humanitarian endeavors as a co-host of the first and longest running public service program aired at GMA-7 Network, "Kapwa Ko, Mahal Ko" with former Senator Orlando S. Mercado. She was also the host of "Mahal," a similar public service program aired at Intercontinental Broadcasting Corporation (IBC-13), while acting as the chairman of her own foundation, the Mahal Foundation;

WHEREAS, she was a staunch advocate of health and wellness. Her active involvement in socio-civic activities and charitable works earned her numerous recognitions such as the Panday Pira Achievement Award, Lahing Kayumanggi Award. Golden Cross Achievement Award and Filipino International Achievement Award:

WHEREAS, she also contributed in the entertainment industry as a movie actress and co-starred in Langit Pa Rin Kita (1967), Basta Bisaya (1970) and Mga Ibong Pipit (1984);

WHEREAS, she entered local politics in 1988 and was elected Councilor of the 4th District of Quezon City;

WHEREAS, among the late councilor's notable legislations in Quezon City was the smoking ban in all public places and the prohibition of urinating, defecating and indiscriminate disposal of waste, trash and any form of garbage in public places;

WHEREAS, the Quezon City government, its officials and residents, mourn her passing and convey their condolences and deepest sympathies to her family, with heartfelt gratitude for her work and legacy as a dedicated public servant.
