RESOLUTION NO. SP- **6705**, S-2016

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, AND THE PHILIPPINE INSTITUTE OF VOLCANOLOGY AND SEISMOLOGY (PHIVOLCS-DOST), REPRESENTED BY DIRECTOR RENATO U. SOLIDUM, JR., TO CONDUCT THE RAPID EARTHQUAKE DAMAGE ASSESSMENT SYSTEM (REDAS) TRAINING THROUGH THE QUEZON CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (QCDRRMC).

WHEREAS, the Philippine Institute of Volcanology and Seismology (PHIVOLCS-DOST), represented by Director Renato U. Solidum, Jr., and the City Government of Quezon City, represented by Hon. Herbert M. Bautista, City Mayor, had entered into a Memorandum of Agreement (MOA) to conduct Rapid Earthquake Damage Assessment System (REDAS);

WHEREAS, under Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code 1991, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance;


WHEREAS, Section 2, Rule 8 of the Implementing Rules and Regulations of Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, states that "the Office of the Civil Defense (OCD) may engage the expertise of the other National Council member agencies and other training organizations accredited by the National Council; "

WHEREAS, one of the powers conferred upon the city mayor under the said Code is to carry out such emergency measures as may be necessary during and in the aftermath of man-made and natural disasters and calamities.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify the Memorandum of Agreement entered into by and between the City Mayor, Honorable Herbert M. Bautista and the Philippine Institute of Volcanology and Seismology (Phivolcs-DOST), represented by Director Renato U. Solidum, Jr., to conduct the Rapid Earthquake Damage Assessment System (REDAS) training through the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC).
